Only the Bishop has the authority to make any such agreement, and then only in writing and indicating that it is intended as a modification of a particular employee's at-will status. Parish Pastors with school responsibility have limited authority, along with the Superintendent of Catholic Education, to enter into a written contract of employment with teachers employed at that particular parish school site. _____
